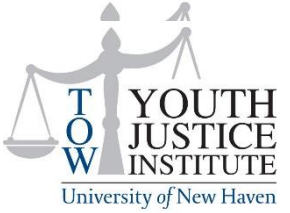

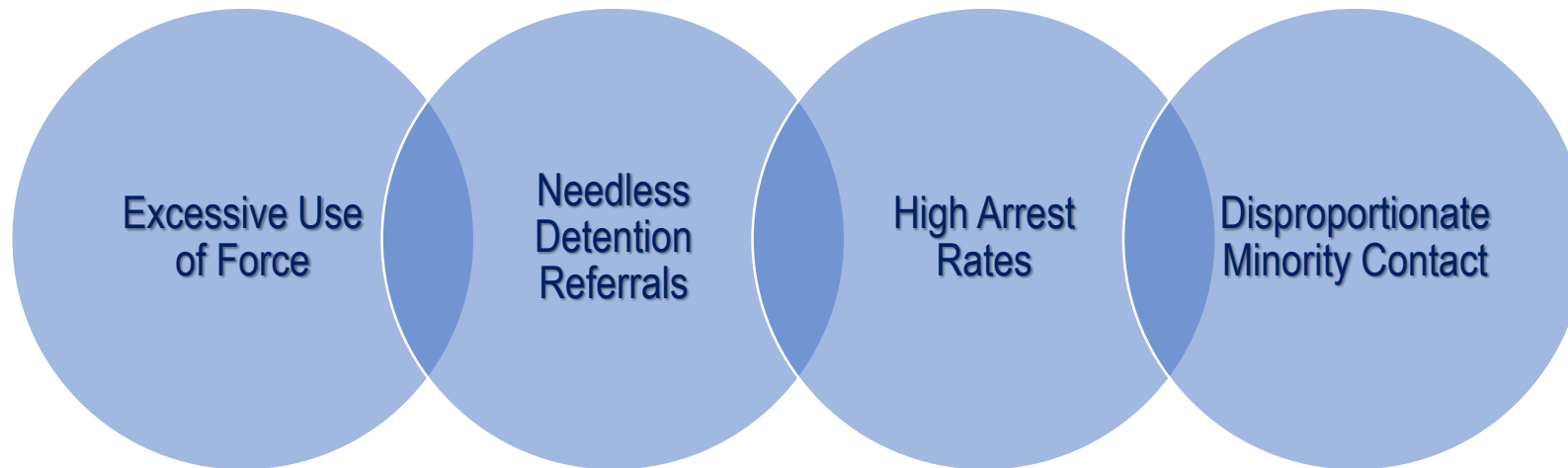

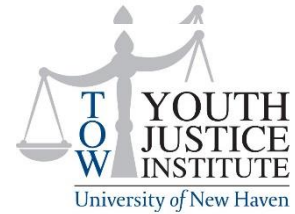

- Juvenile Justice Landscape in Connecticut

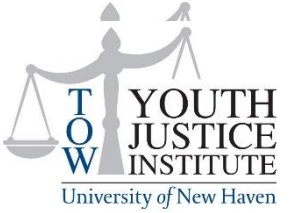
High Rates of Disproportionate Minority Contact

- **Recruitment Plan**

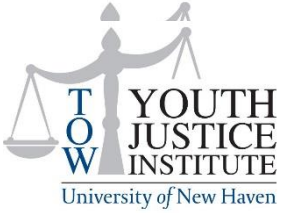
Identify police officers to:

- Learn practices for developing strong police/youth relations
- Use a central city/suburban approach (Pilot in Hartford County)
- Develop regional networks of police officers in CT promoting best practices for policing youth and attuned to youth and juvenile justice issues

Recruitment Considerations:

- Officers involved: Patrol, gang unit, community engagement officers, and school resource officers
- We will recruit from high arrest areas in Hartford County and select 15-20 participants
- Police Leader Mind Set/Change Agent's Courage

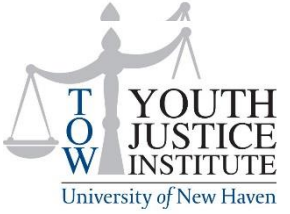

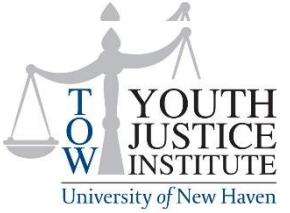


- Capstone Project

The achievement of these goals will promote the following outcomes. They will be derivatives of the curriculum and reinforced through the capstone project.

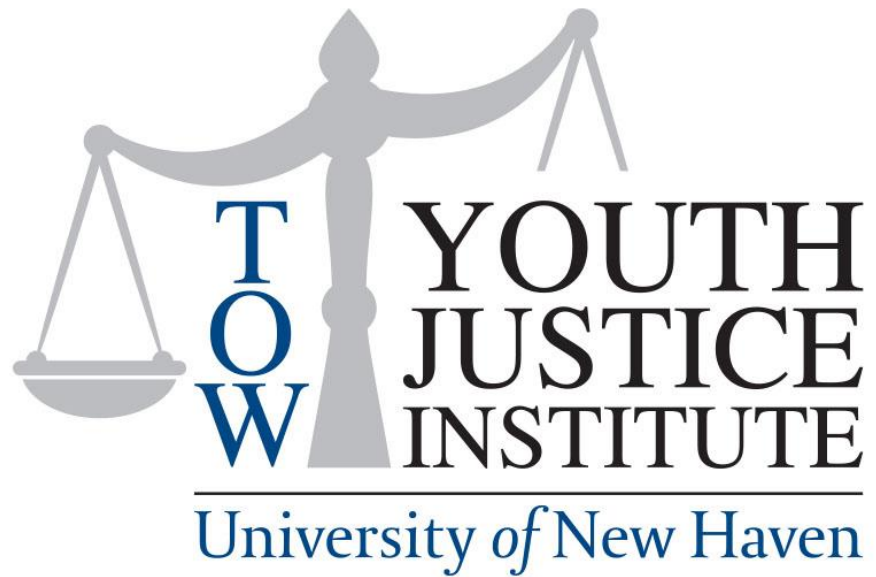
