Goal #3	Strengthen Connecticut's network of Restorative Practices offerings by building up the infrastructure so they are more easily accessible to youth and families.

- Attended each of the six quarterly meetings and receive from and offer information related to our shared work on front-end diversion and reducing racial and ethnic disparities.
- Collaborated with the Judicial Branch, who produces the public reports Reviewed data from edgisght.gov for education population data
- Completed interviews to collect feedback related to selecting or referring youth, intake process, determination of service needs, completion determination, discharge process, engagement with parents and the community as partners, and data collection strategies and obstacles.
- Discussed the role of COVID-19 on the services they provided and the relationships that they had build with youth and/or community partners.
- Data analyzed and drafted for the overall OJJDP report that will be produced at the end of the grant period.
