OUR PROGRAMS/Referral requirements

Outpatient Services

Accepted from individuals and community organizations

Behavioral Health Clinics in Bridgeport, Norwalk, Stamford and Waterbury provide services to individuals 13 years of age and over (18 years of age and older in Waterbury) with addiction, mental health, co-occurring disorders, trauma and gambling issues. The clinics accept Medicaid and Commercial Insurances or sliding scale for the uninsured. The ASIST Program, at our Norwalk location, provides services which are criminogenic and clinical in nature in a supervised, community-based alternative to incarceration.

LYNC/Linking Youth to Natural Communities

Accepted only from probation officers

With offices in Stamford, Bridgeport, New Haven and Waterbury, this program provides services to adolescents and their families who are court-involved and struggling with substance use, anger management, trauma and/or family issues.

Waterbury West Residential Treatment

Accepted from CT courts and from Adult Probation of the Court Support Services Division

Located in Waterbury, this program provides 90-day residential treatment services to men 18 years of age and over who are in need of substance use treatment. Services include individual and group counselling, 12-Step meetings, case management and life skills training.

McAuliffe Center for Co-Occurring Disorders

Accepted from hospitals, detox and community programs

Our Co-Occurring intensive residential program is located in Waterbury and serves men 18 and older. This program provides 30-45 day clinical care that is targeted to the clients' acute behavioral health and substance use needs. Services include individual and group therapy, psychoeducation and medication management. If needed, clients can be referred from this program to a longer-term environment.

DWI/DUI Drug Education Programs

Accepted only from Connecticut courts or individuals arrested outside the state who have been allowed to attend Alcohol/Drug Education programs in CT

This program serves first-time DWI/DUI offenders utilizing 10- or 15-session education programs. Evaluations and group education programs are held in Stamford, Norwalk and Bridgeport.

Community Work Release Programs

Available only to individuals referred by the Department of Correction


Connecticut Renaissance operates work release programs in both Waterbury and Bridgeport. These programs are designed to help individuals reenter the community from incarceration. Clients work with their case manager on life skills and also with a job developer to seek and obtain employment.
