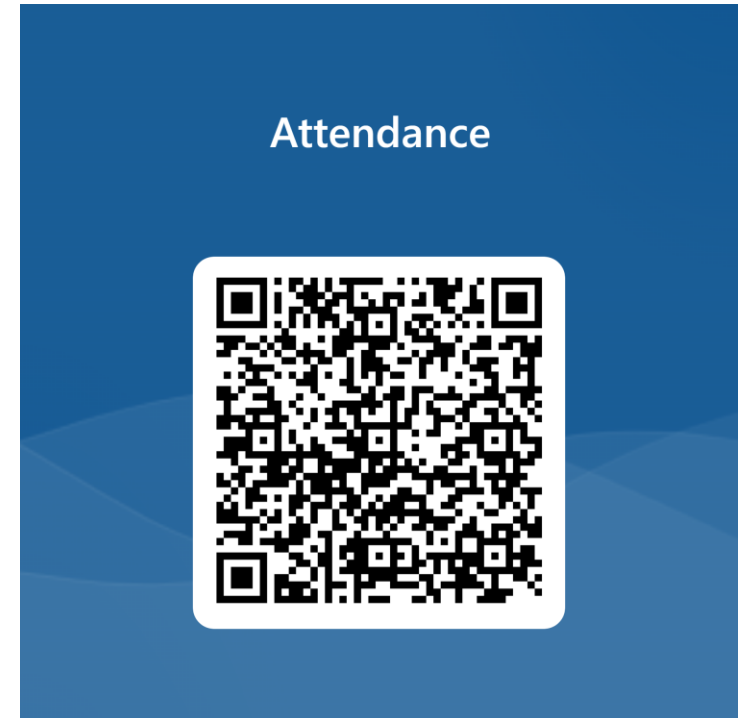
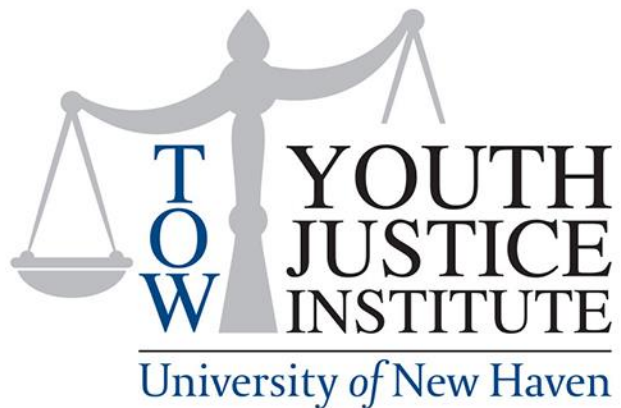

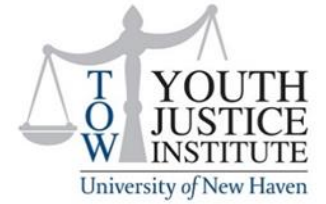

Members received an introduction on Urgent Care Crisis Centers, including service delivery and challenges.

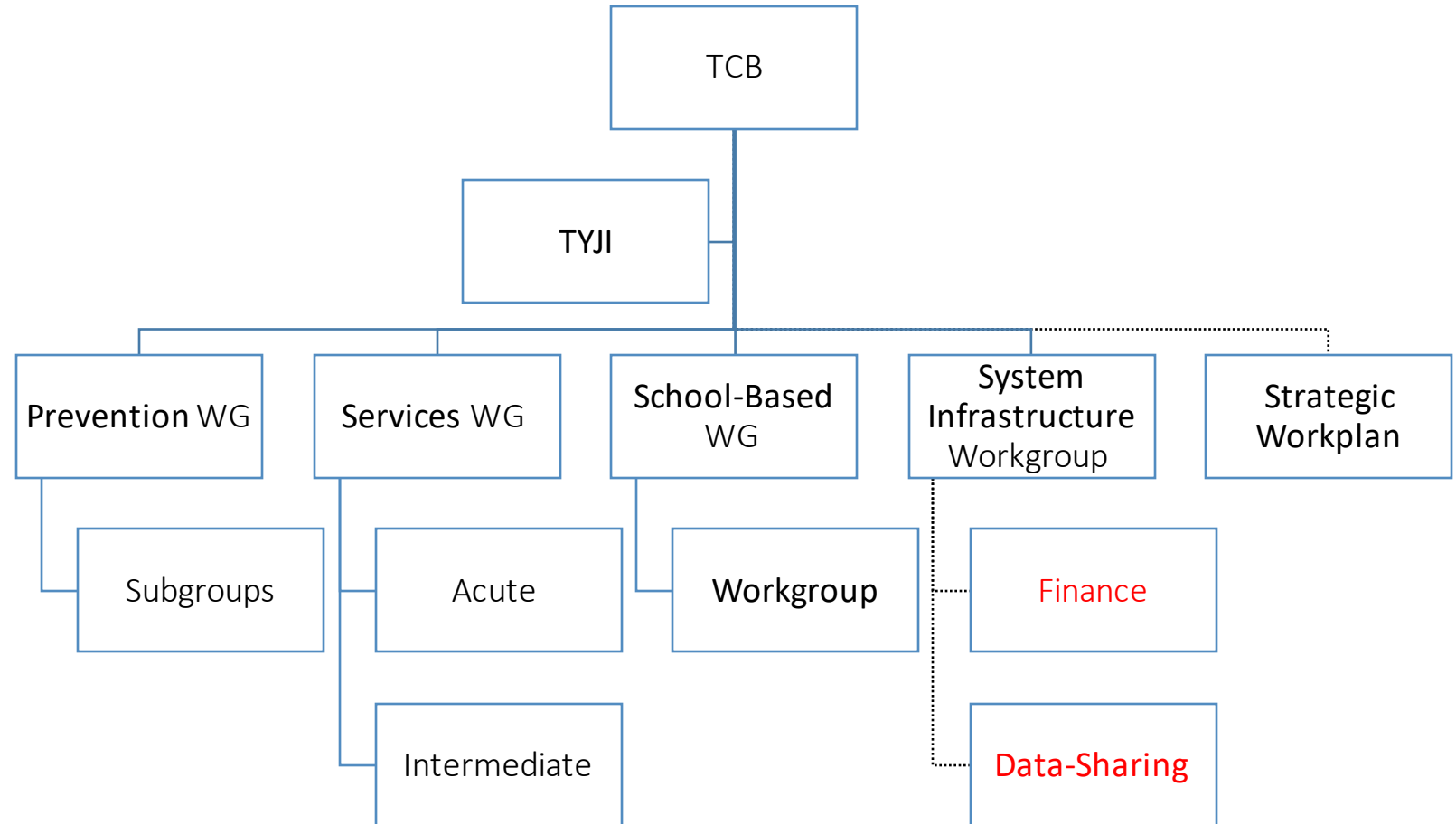

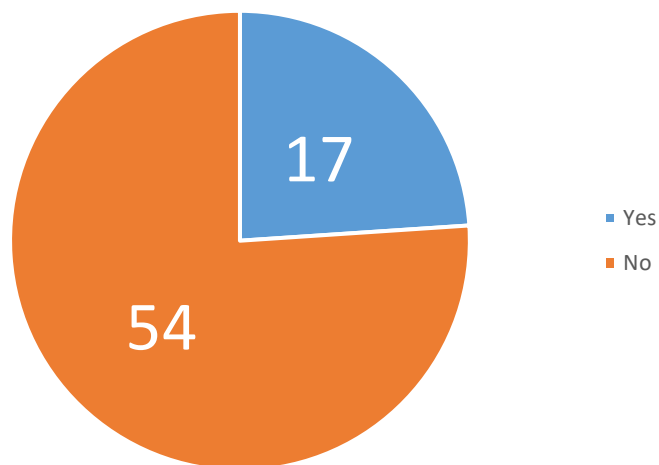
Feedback on Organizational Chart

- Consider **Services** as workgroups with subgroups as needed for specific types e.g. school-based, acute, intermediate

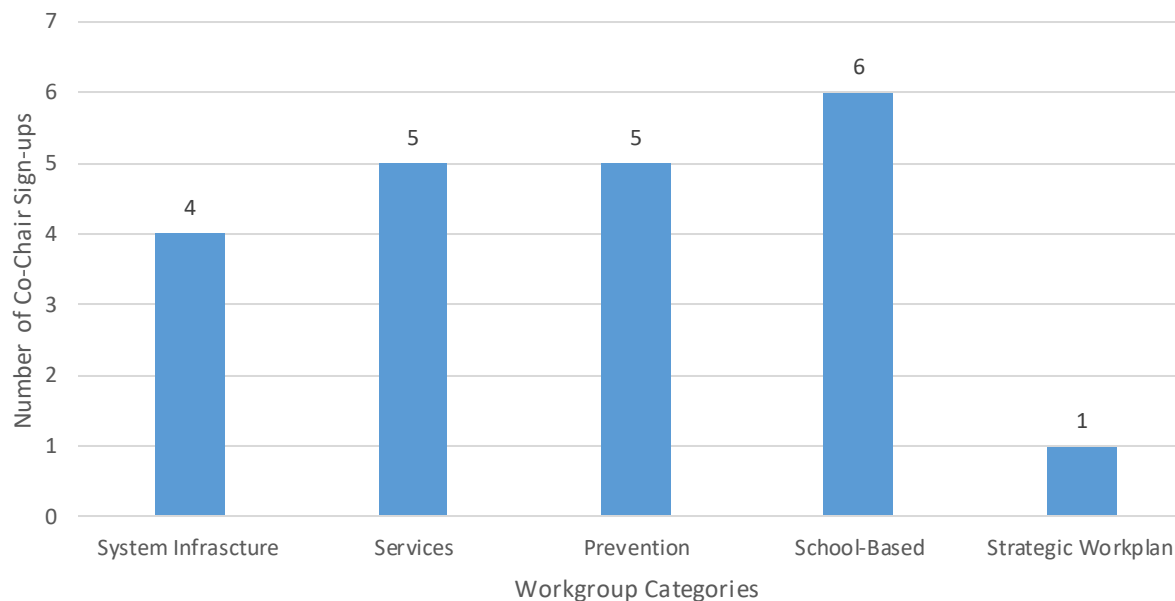


Workgroup Co-Chair Candidate

TCB Statewide Listening Session Roadmap



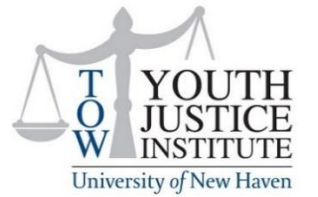
