TCB Gender and Race Composition Data

As you may be aware, pursuant to Connecticut General Statutes Section 4-9b, certain state boards and commissions are **required to biennially report the gender and race composition of their membership to the Office of the Secretary of the State (SOTS)**. More information about the report and these efforts are found on the SOTS website under Gender and Racial Composition Report. The SOTS office is required to collect this data between September 1 to October 1, 2025, and issue a biennial report no later than January 1, 2026. To that end, we ask that all TCB members and their designees complete the following survey.
